MEMBERSHIP

Qualifications as Patron Member

1. Persons or firms endorsing the paralegal concept or involved in the promotion of the paralegal profession; or
2. Those members of the educational field endorsing the paralegal concept or involved in the promotion of the paralegal profession; and
3. Payment of annual membership cost.

Patron Members are voting eligible, however, ineligible to hold officer positions.

Qualifications as General Member

1. A North Carolina Certified Paralegal (NCCP) as certified by the North Carolina State Bar Board of Paralegal Certification (submission of certificate); or
2. A Certified Legal Assistant (CLA)/Certified Paralegal (CP) as certified by the National Association of Legal Assistants (NALA) (submission of certificate); or
3. Successful completion of a curriculum of paralegal training and employed under the direct supervision of a licensed practicing attorney (submission of certificate and supervising attorney completion of Attorney Attestation); or
4. Completion of three (3) years of continuous on-the-job training as a paralegal under the direct supervision of a licensed practicing attorney (supervising attorney completion of Attorney Attestation); and
5. Payment of annual membership cost.

General Members are voting eligible and eligible to hold officer positions.

Associate/ Student Membership

1. Successful completion of a curriculum of paralegal training but not currently employed as a paralegal (submission of diploma or certificate of completed program); or
2. Employed for three (3) years as a paralegal under the direct supervision of a licensed practicing attorney (supervising attorney completion of Attorney Attestation); or
3. Enrolled as a student in a paralegal education program (school completion of School Attestation); or
4. An individual, attorney or paralegal program representative who endorses the paralegal concept or is involved in the promotion of the paralegal profession; and
5. Payment of annual membership cost

Associate/ Student Members are ineligible to vote or hold officer positions.
